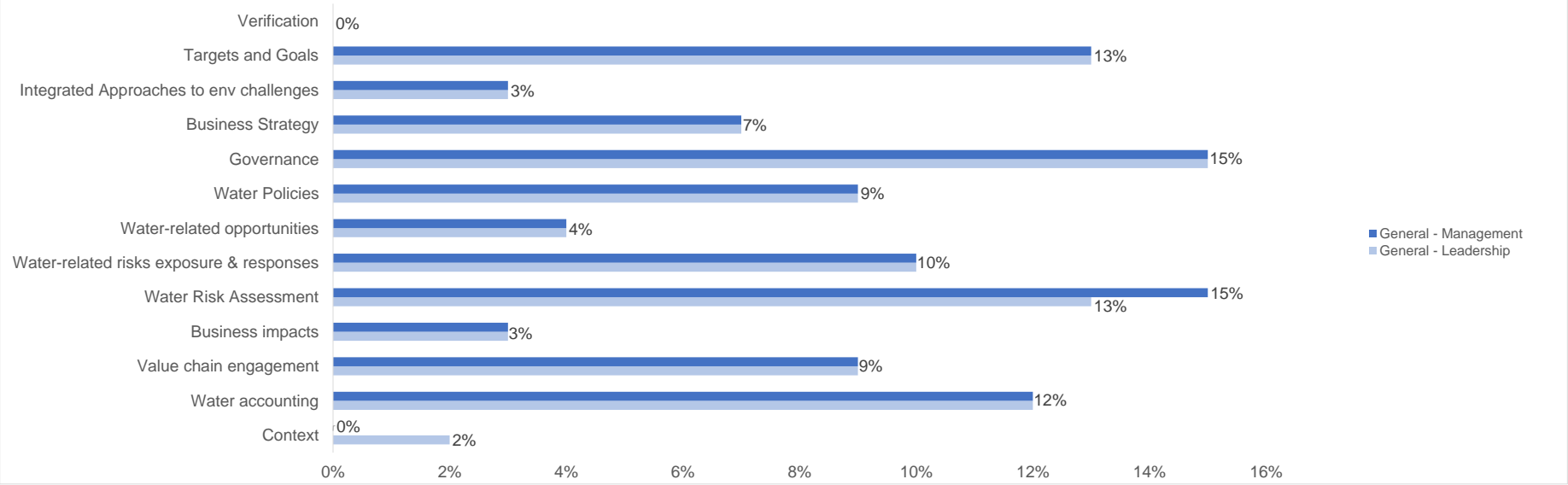

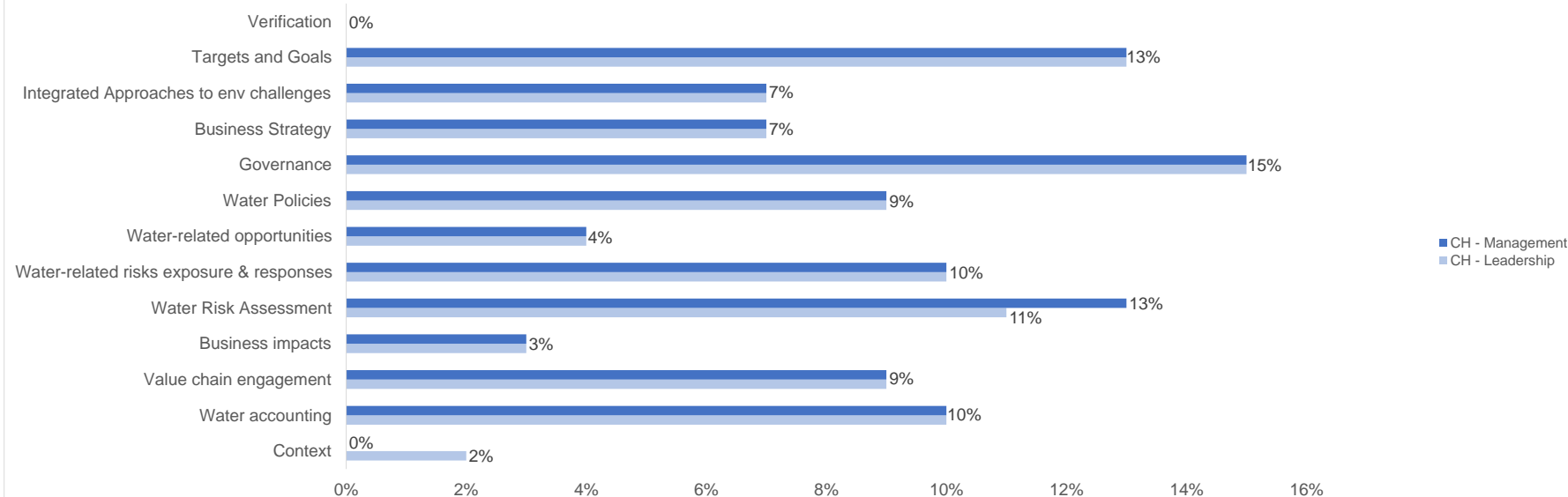

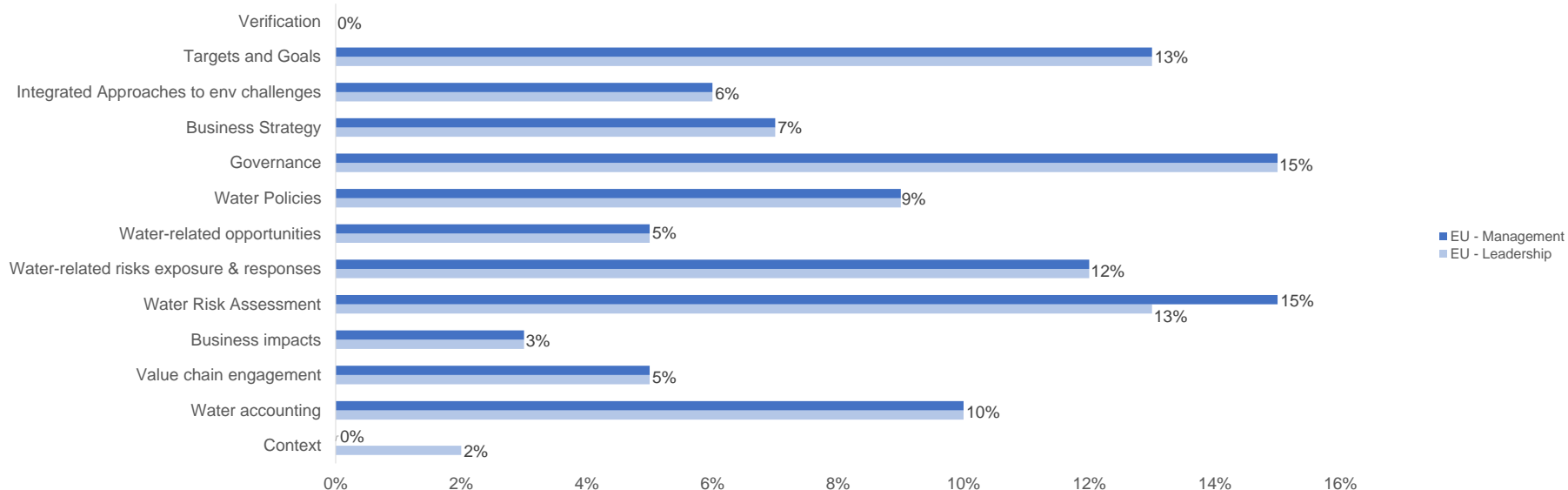

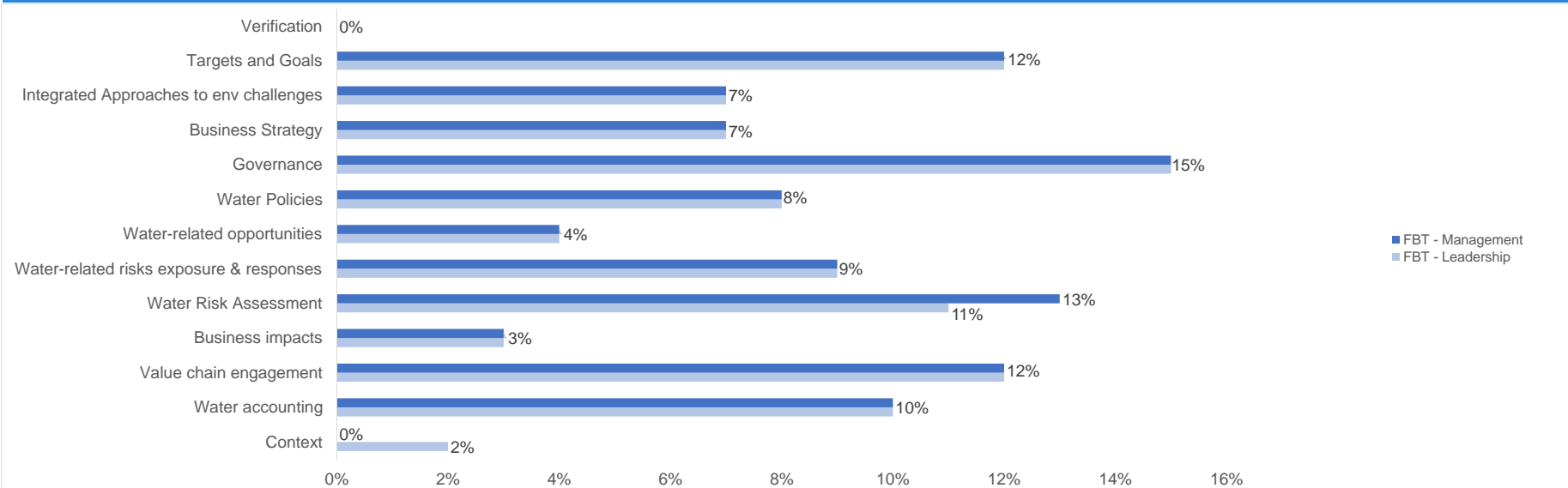

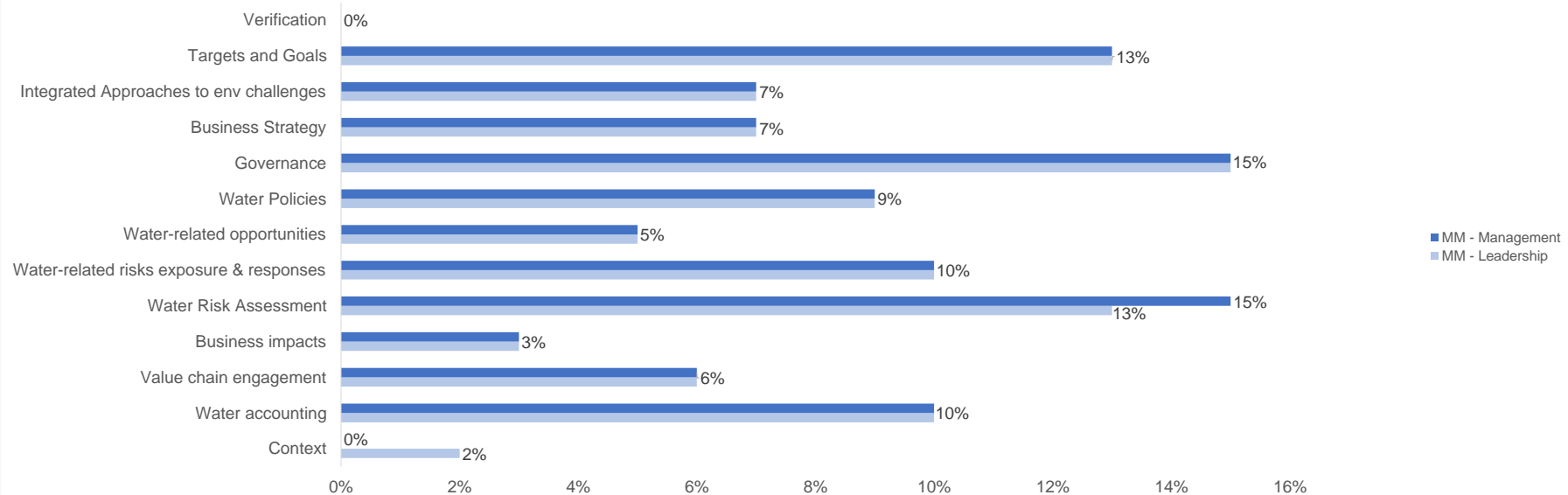

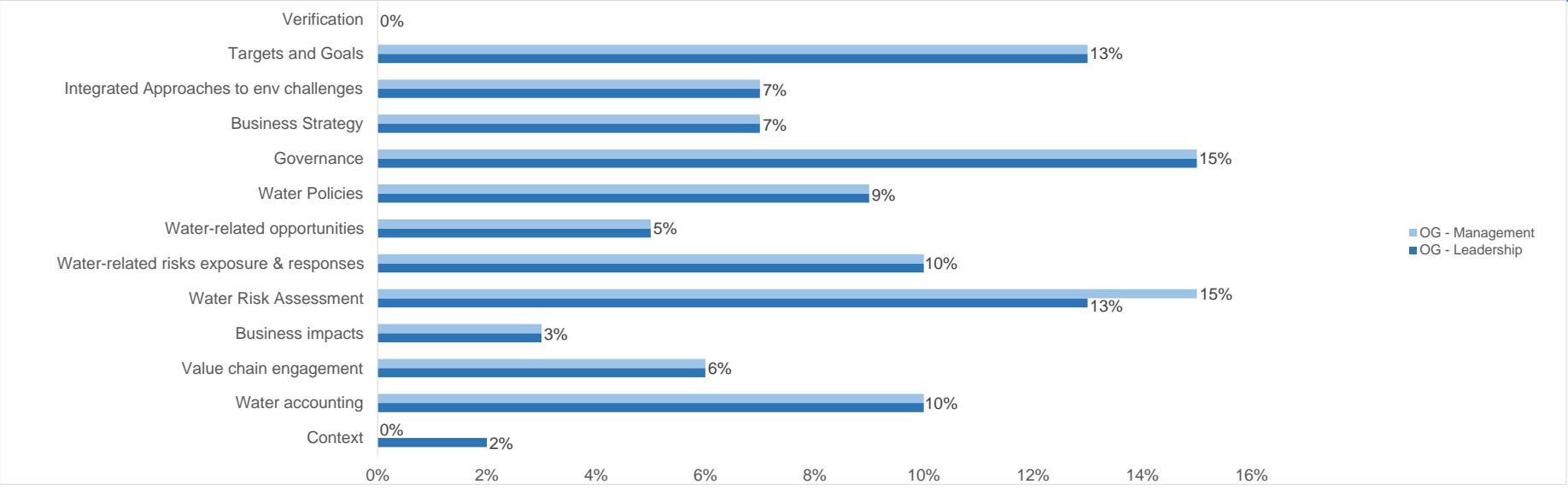
Scoring categories & weightings: an overview

Scoring categories are groupings of questions by topic. They are sub-groups of the 2021 questionnaire and are consistent across all sectors. Weightings are applied to scoring categories at the Management and Leadership levels only. Weightings reflect the relative importance of each category in an organization progression towards environmental stewardship, within the boundaries of the CDP questionnaire and available scoring criteria. As such, the weighting applied to each category varies across sectors to highlight the areas most important to environmental stewardship in specific sectors.

2021 Scoring categories

The 13 scoring categories in 2021 are: Context; Water accounting; Value chain engagement; Business impacts; Water Risk Assessment; Water-related risks exposure & responses; Water-related opportunities; Water Policies; Governance; Business Strategy; Integrated Approaches to Environmental Challenges; Targets and Goals; and Verification.
